New Member Bio – Suzette Maier

I grew up in Maumee, Ohio which is a suburb of Toledo, Ohio. I am an only child. My father was my greatest influence and hero. I married and have one son, Jim White. When our son was eight, we began shooting target archery. I won three NFAA Indoor Nationals, Ladies Open Division, in 1982, 1983 and 1984. I have enjoyed many crafts over the years. Quilling, making hand-sewn and painted Christmas ornaments, and cross stitch. I also made porcelain dolls which included cleaning the greenware and painting faces using oil paint.

I went to my first quilt class in 1993 at the Quilt Foundry in Maumee, Ohio. As a perfectionist, I get frustrated and have many UFOs. My favorite is doing both wool appliqué and embroidery. I belonged to the Gathering of Quilters in Toledo, founded in 1982, and the Ann Arbor Quilt guild in Ann Arbor, Michigan. I sewed with four friends every month until moving to Arkansas in 2012. I miss sewing with a small group of friends.



I joined Hill N Hollow around 2013. I went as Sue Herron's guest and joined that day. I have sold tickets for the raffle quilt over the years. My profound deafness impacted my volunteering. I have taken a guild class but it was too difficult to hear and follow. I attended several sew-ins. I wanted to be with people but was isolated by deafness. Hearing aids didn't help with word comprehension.

I have avoided large groups for many years. My favorite thing to do has been to read books because it takes me places that I don't need hearing to enjoy. I've read 120 books this year. My hearing loss began after German measles and ear infections in the 50's.

My recent Cochlear Implant surgery and activation has been life changing. I went to the quilt show the day after activation, was walking and stopped dead in an aisle. I realized I was hearing raffle tickets numbers being announced over the PA. I clearly heard every single number! I was able to speak with Rosita and Sharon Crozier. A couple weeks ago, a huge sound froze me in my chair. I knew it wasn't the dishwasher or washing machine. I glanced out the window and it was raining! I was hearing rain on the roof of my house. Every time I go somewhere, I am having "first time" moments. I am so grateful and amazed at my new world.

- I. CALL TO ORDER 9:34 AM
- **II. IN ATTENDANCE:** 61 guild members and 7 guests

III. PRE-MEETING ANNOUCEMENT:

- A) Vote for 2024 Officer Nominees-If there are any nominations from the floor, please present written consents now.
- B) Members Garage Sale-President Forster indicated that the garage sale tables were located in the back of the auditorium.
- C) RSVP for December Lunch-Sign in sheets were distributed during the guild meeting
- D) 2023 Raffle Quilt-Drawing to be held December 8th at the guild meeting.

- E) 2023 Quilt Show Pin-\$12.00 per pin. If interested see Judith or Rita.
- F) 2024 Branson Retreat Registration-\$130.00 per person, retreat is March 4th-7th, deadline to sign up January 2, 2024.
- G) 40th Anniversary Pin Order and Purchase
- H) Help Desk-President Forster reminded guild members to take advantage of the Help Desk run by Vicki Kauth.

IV. WELCOME:

- A) President Forster welcomed guild members to the meeting. She recognized guests that were in attendance. Birthdays and anniversaries were acknowledged. President Forster made special mention of Mary Ann Geisy who used to be a quilt guild member, moved out of the area and has now returned to the Twin Lakes area and is returning to the guild. Fabric birthday cupcakes were handed out to November birthday members.
- B) President Forster stated that she received a card along with a \$100.00 donation to the Hill N Hollow Quilt Guild in Betty Pulver's memory from the Mallard Point Homeowners Association.
- C) President Forster stated that during the quilt show a gentlemen came up to her asking for assistance. His wife had recently passed away and he was hoping that the guild or one of its members could help him sell her quilting items. President Forster stated that she encouraged him to seek out local estate sale companies in town, but stated to him that she would mention it at our guild meeting to see if anyone was interested in helping him out of the "goodness of their hearts". President Forster stated that if anyone is interested, she has his name and phone number.

V. BUSINESS REPORTS:

Treasurer's Reports

A. President Forster indicated that the Treasurer's Reports for the months of September and October will be submitted to audit.

VI. WHAT'S WHAT:

- A) <u>Baxter Co Quilt Show Report:</u> Jonna Butler, Quilt Show Chairman, reported that the quilt show was a success! There were 571 paid visitors to the two days show and that guild made money on this community event. There were 61 volunteers that made the quilt show a success (see attached list). Jonna thanked everyone that contributed to the success of the quilt show. She also stated that Carolyn Bisbee is taking the position of Quilt Show Chairman for the scheduled quilt show in 2025.
 - B) Raffle Quilt Sales to Date/Holiday Gifts at Stone Creek: President Forster stated that raffle quilt sales to date are \$2,980.00. The last raffle ticket selling is at Stone Creek for the Holiday Gifts event happening on the 17th and 18th. This event is occurring in conjunction with an event at the Baxter County Fairgrounds for the Craft Sale on November 17th and 18th. Jonna Butler won the most tickets sold in September 2023 for the raffle quilt. In October Jodi McCray won for the most tickets sold.
 - C) <u>Retreat 2024</u>: 25-30 people have signed up so far with a maximum of 50. If interested, need to get registered. There is a short meeting after the guild meeting for committee members.
 - D) <u>Hospitality Expenditure Request:</u> President Forster stated that Board Members approved and recommended an increase of \$500.00 for a total of \$700.00 to help cover the December luncheon.
 - A. Darlene Landrum moved to approve holiday expenditure request. Sue Herron 2nd the motion.
 - C. There being no discussion, approval was so ordered without objections.
 - D. Signup sheet for members that were interested in attending was passed around during the guild meeting.
 - <u>E) Vote for 2024 Officer Nominees</u>: Requested written nominees from guild members none presented. Officer nominees: Carolyn Bisbee in 2024 will be Vice President, Celine Kingsland will remain as Treasurer with Secretary and President Elect positions remains open.
 - A. Patti Kratz moved to approve positions already filled. Dianne Petty 2nd the motion.
 - C. There being no discussion, approval was so ordered without objections.
 - <u>F</u>) <u>Standing Rules Revision Proposals</u>: President Forster stated to the guild members that the board approved these revisions and that it was being presented to the guild members. She stated that the Standing Rules Revision will be emailed to all guild members for their review so that it can be approved at the December guild meeting. President Forster also stated that the By-Laws will be the responsibility of the incoming Officers in 2024.

- G) **Gift Giveaway**: Angie Lindberg announced that members could enter into the drawing if they wore their name tag to the meeting. This was a left-over gift that no one claimed from the Fun and Games Committee during the quilt show.

Her main message was that quilting is a learning experience "there are no bad UFO's", learn to accept constructive criticism because you will LEARN, and ask for HELP.

EVERY QUILT HAS A STORY PRESENTATION: Ginger Alexander presented her elephant memory quilt from silk fabrics that she bought while visiting Thailand. Ginger stated that every time she looks at this quilt it brings back wonderful memories.
